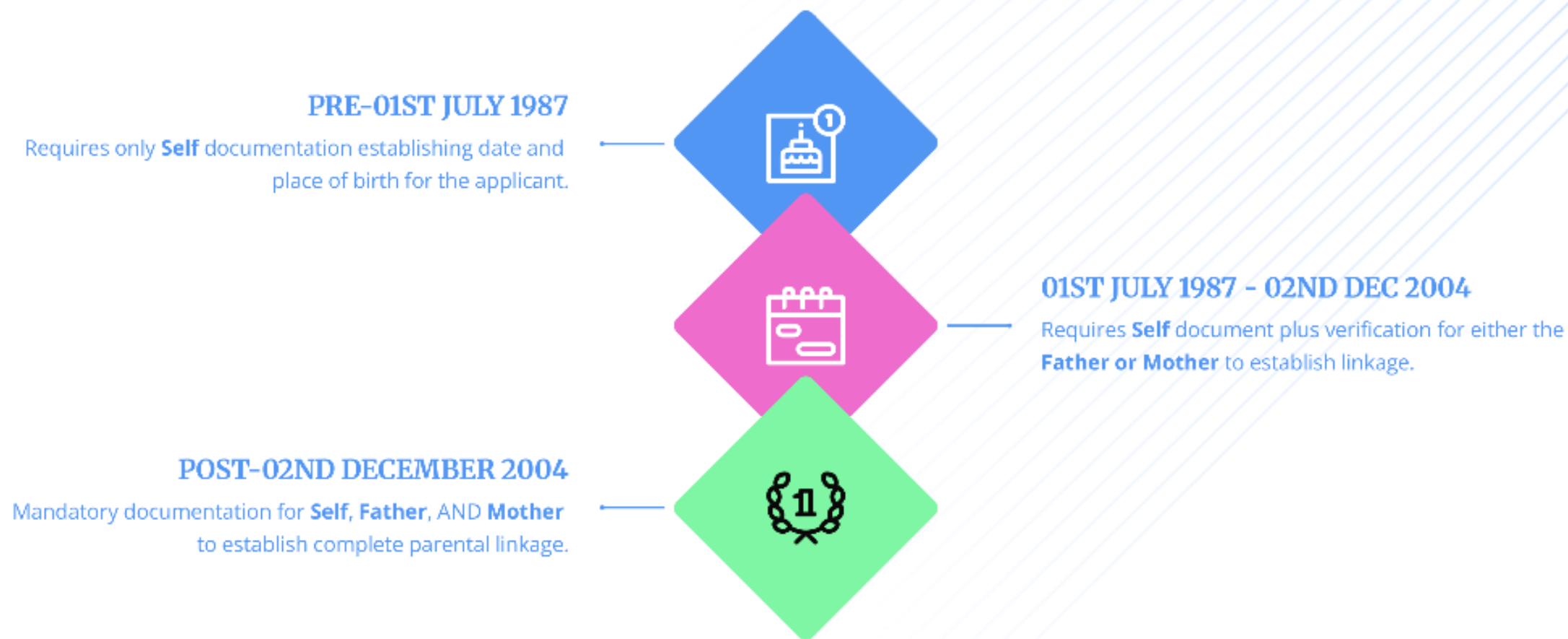

1	Elector has not provided any document and pending for disposal	Ask ERO why case has not been heard and disposed of
2	Only Aadhaar has been provided	Reject the application and decide the case accordingly

	Observation	Action recommended
3	Only Aadhaar and so-called family register/ SECC enumeration data submitted	To be rejected and decided thereupon.

	Observation	Action recommended
5	Birth certificate, admit card, caste certificate of self-submitted but borne after 01.07.1987. - No other document which proves linkage to either of Parent date of Birth/Place of Birth if borne in between 01.07.1987 and 02.12.2004 or thereafter.	Doubtful and to be rejected.
6	Birth Certificate, SIR extract of either parent but Name doesn't match of either parent- No other document which proves linkage to either of Parent date of Birth/Place of Birth if borne in between 01.07.1987 and 02.12.2004 or thereafter.	To be rejected and ERO/AERO/BLO be under scrutiny.

	Observation	Action recommended
7	Only Aadhaar but claimed SIR 2002 extract of either parents or Grandparents- Total mismatch of names are found or no linkages specially in cases of grandparents to parents	To be rejected and ERO/AERO/BLO be under scrutiny.
8	Name on Enumeration form and documents submitted are having a mismatch	To be rejected and ERO/AERO/BLO be under scrutiny.

	Observation	Action recommended
9	Signature on Enumeration form and Hearing receipt are different eg- LTI in one and signature in other	To be rejected and ERO/AERO/BLO be under scrutiny.
10	Thumb impression on Enumeration form without specifying details about person	To be rejected and ERO/AERO/BLO be under scrutiny.

	Observation	Action recommended
11	BLO and AERO had submitted document of X category, but actual petitioner belongs to Y category	To be rejected and Suspicious role of BLO/AERO
12	SIR extract uploaded by AERO/ERO without seeing what has been uploaded. Often in such cases it is first and last page of Extract	To be rejected and ERO/AERO/BLO be under scrutiny.

	Observation	Action recommended
13	BLO did not uploaded delivery receipt or photo	Suspicious role of BLO/AERO
14	Same Elector photo has been uploaded in two cases for hearing	Suspicious role of BLO/AERO

	Observation	Action recommended
15	Irrelevant documents submitted (e.g., land deed; self-affidavit before executive magistrate regarding change of name/heirs; individual house allotment orders; Panchayat <u>Sarpanch</u> certificates; private school leaving certificate showing DoB, etc.)	To be rejected and suspicious role of BLO/AERO
16	OBC certificate between 2010-2024.	To be rejected as per Courts direction.
